He and his wife Ruth were our very first donors, establishing the Harold and Ruth Moss Charitable Fund in 1997. 
Teachers attending a summer training on the Orton-Gillingham method for reading instruction for children with dyslexia.

# Specialized Training This Summer

30 teachers develop new skills to work with dyslexic students

Several years ago one of our donors expressed interest in what was being done in the schools for students with dyslexia. This reading disability is much more common than people know. Statistics show that as many as one in five students are affected by some degree of dyslexia. Many students are not diagnosed or do not receive adequate reading support and intervention. As a result, they may be behind grade level in reading or never learn to read effectively.

Waldeck Nursing
Scholarship Now in
Seventh Year

Our program staff met with special education administrators at School District 51 and parent support groups to identify opportunities for addressing the needs of dyslexic students. The idea of bringing a national expert with a specialized teaching methodology to train our teachers this past summer emerged as an exciting new initiative.

Our donor has a child who benefited greatly from the Orton-Gillingham (OG) method and funded 80% of the cost of the week-long training held in July. This made the program more affordable for teachers who attended the training on their own time over summer break. Thirty spots were available and the program filled almost immediately. Notes our donor, "we were so pleased to be able to offer teacher training in the OG approach. This will have a big impact on the educational success of so many dyslexic kids."

Because of our donor's initiative and generosity, a small corps of teachers are now equipped to better help students with dyslexia and other reading disabilities in our classrooms. One participant's comments reflect the spirit of the whole group. "Because of your generous underwriting, I was able to afford and participate in this amazing training. I have acquired many new skills and will be able to help so many students when the school year begins."

This dyslexia training initiative is a compelling example of our mission *to connect people* who care with causes that matter.

Students in Mesa County School District 51 and other counties in Western Colorado we serve headed back to school with adequate nutrition to start the new school year with a bang. Thanks to a strong partnership with D51 Nutrition Services, the Lunch Lizard Summer Mobile Meals Program expanded from one food truck in 2015 that served five locations to two food trucks this summer that served twelve locations. The number of meals served were more than triple what they were in 2015, with 15,700 meals served to children in their neighborhoods this summer. Kids Aid provided over 2,600 weekend bags of food for children through the program.

Our Community Foundation also provided grant funding to support summer mobile meals regionally, including new programs in Delta, Garfield and Eagle Counties. We also supported a new program in Fruita through the Fruita Rotary Club. In total, nearly 18,700 meals were provided to children this summer.

A huge thank you to our many donors and volunteers who helped make Lunch Lizard 2016 a huge success, including Rocky Mountain Health Plans, Lions Club, Alpine Bank, Share our Strength and many caring individuals in the community.



The board of D51 Foundation, the independent nonprofit organization raising funds for district-wide initiatives, has met a matching challenge issued by our Community Foundation at the beginning of summer. Several teams of board members have been busy conducting fundraising events - home garden parties, restaurant nights and a benefit bike ride. Our Community Foundation is supporting these efforts by providing a \$20,000 match from two of our donor-advised funds.

New funds will purchase four tech carts, each loaded with 30 Chromebooks, for elementary schools piloting the new Performance-based Learning (PBL) approach adopted by School District 51. The new technology allows District students to engage in individualized learning and mastering content at their own pace, a key component to the Performance-based Learning approach.
